Who can collect pledges?

Who can we collect pledges from?

Individuals or businesses, the list is endless—be creative and seek support!

Are tax receipts provided?

All pledges over \$15 are eligible for a tax receipt.

How is the 'winner' determined?

There will be only four individual or sibling groups identified as the 'winners'. In order to be identified as the 'winners' the following guidelines must be met:

- A minimum of \$250 in pledges collected;
- Be 17 years old or younger;
- Be one of the four highest fundraisers overall.

What if there is a tie for top fundraiser?

If there is a tie for highest fundraisers a tie breaker will occur. All fundraisers with the highest funds raised will be entered into a draw. The first to be picked will get the highest prize available (in the case of a tie between fundraisers for prizes 2-4). the second picked will get the next highest prize, and so forth.
